Announcing New Program Director for Mass Hlway

Bert Ng has joined the Mass Hlway as its Program Director. The Mass Hlway, within the state's Executive Office of Health and Human Services, offers doctors' offices, hospitals, laboratories, pharmacies, skilled nursing facilities, and other healthcare organizations a way to securely and seamlessly transmit vital data electronically. Mr. Ng is responsible for overseeing all policy, business, and operational aspects of the Mass Hlway, including the setting and implementation of strategic policy and technical goals, and engagement with external stakeholders in other state agencies and in the public.

Mr. Ng is a seasoned policy advisor to senior leaders and executives in public and private organizations. He served as senior healthcare analyst and legal counsel to House Chairman of the Joint Committee on Health Care Financing in the Massachusetts legislature from 2009 to 2013. He continued his state service as a project manager conducting economic analyses for the Cost Trends and Research team at the Health Policy Commission from 2013 to 2016. Most recently, he was a Senior Manager working on federal reimbursement policy in the Washington, D.C. office of a biotech company.

Mr. Ng led the House drafting process for the 2012 Health Care Reform Law, Chapter 224, including Chapter 118I. In addition to crafting Chapter 118I, he worked with the HIT council and MeHl during his time in the legislature in the early development stages of the Regional Extension Center and Health Information Exchange.

"I'm excited to be joining the Hlway team to promote adoption of the Hlway and further leverage its ability to improve patient care," said Ng.

HIE Success Story



Brigham and Women's Hospital (BWH) often requires specialists to come from Boston Children's Hospital (BCH) to evaluate and consult on patients in the BWH Neonatal Intensive Care Unit (NICU). During this process, consultant notes are generated and must be sent between the two hospitals. In the past, this was causing a lag in services and required providers to take additional steps to ensure the notes were sent correctly and

efficiently from BWH to BCH. Considering the need, providers at BWH identified an opportunity to streamline the process of sharing consultant notes between the hospitals.

Keeping current systems in mind, a new process was implemented to share information using the Mass Hlway: once a request has been sent from BWH for a BCH consultant, the BCH consultant will come to the BWH NICU, assess the patient, and write their consult notes in the Partners instance of Epic, BWH's Electronic Health Record (EHR). After the note is signed by the BCH provider, a background process carried out by the Partners HIE Hub identifies this note as a document that needs to be shared with BCH, since the patient may have a need for further services from BCH in the future. The document is then sent to BCH via the Mass Hlway as a PDF file.

BWH and BCH had several goals and objectives when developing this workflow. The main focus was to have the system eliminate and mitigate errors that arise from using paper and faxing or scanning of records. Providers at BWH and BCH are pleased to see how leveraging the Mass Hlway and creating this background process has worked to streamline information, lessen the likelihood of lost records, and overall make the process more efficient and less time consuming. Update: Hlway 2.0 Migration

As the Mass Hlway completes the remaining Clinical Gateway (CG) Node migrations to Hlway 2.0, the team would like to recognize and thank those who have supported this important work. You are part of the growing list of Participants who have migrated to Hlway 2.0.

In particular, we appreciate the patience and assistance of the Public Health agencies and Hlway Participants who were asked to resubmit certain transactions or help research the status of messages sent during certain times.

The Mass Hlway team, including our colleagues at Orion Health, worked hard to address issues related to the stricter national standards enforced by the new CG Nodes. Likewise, extensive infrastructure enhancements have been implemented to handle the shift of the Hlway's significant traffic volume to the new environment. These improvements will provide robust support for the full scope of Hlway 2.0.

Fall HIE Workshop

There's still time to register for the November HIE Workshop.

Mass Hlway's HIE Workshop will provide an educational opportunity for

healthcare providers to increase the effective use of Health Information Exchange (HIE).

Over the course of two sessions, we will present the fundamentals of process improvement and change management strategies, and discuss how to apply these strategies to improve clinical workflows by incorporating HIE technologies including the Mass Hlway.

Using insights gained through our Spring 2018 HIE Learning Collaborative, we will share best practices to effectively implement HIE, and provide tools and resources to help organizations incorporate HIE into their workflows to manage the electronic health information they send and receive.

The HIE workshop will be presented this fall:

- Part one, on Friday, November 9, will focus on Change Management
- Part two, on Friday, November 16, will focus on Process Improvement

In an effective organization, leadership happens at all levels. This course is intended for anyone who participates in, influences, or leads HIE projects: clinical and IT managers, care providers, analysts, and other staff.

Participants are strongly encouraged to attend both parts one and two. In part one, we will conduct team exercises to support the concepts and for participants get to know each other. In part two, you will work with other participants to map several HIE workflows based on what you have learned.

Attendance by multiple participants from a single organization is optimal. In this case, we request that at least one person from the organization attends both parts of the workshop.

The workshops will be presented by the Mass Hlway, in collaboration with MeHl, the Massachusetts eHealth Institute. Sessions will be hosted at MeHl's Weiss Conference Center in Westborough, MA.

2019 Connection Requirement

For 2019, the <u>Mass Hlway Regulations</u> (101 CMR 20.00) require all Acute Care Hospitals, all Community Health Centers, and Large and Medium Medical Ambulatory Practices to connect to the Mass Hlway. These organizations must meet the requirements by January 1, 2019, and must attest that they met the requirements by July 1, 2019.



The 2018 Mass Hlway attestation deadline has passed. If you did not submit your organization's mandatory attestation, please do so soon to meet the requirement set forth in the Mass Hlway Regulations. Attestations must be submitted by all Acute Care Hospitals, Large Community Health Centers, and Large and Medium Medical Ambulatory Practices.
